# 2 Presentations/Appointments

a) Paul Riley - Cemetery Trustee

Bill Weiler and Dean Geddes came in to discuss their decision on Harding Hill Farm to do the tree cutting at the South Newbury Cemetery. Weiler read a written statement regarding the fragile gravestones which are very expensive to replace, the use of equipment at the cemetery, and how the trees were over and running through the gravestones. They do not want bucket trucks used as there is no access road. Harding Hill who is Tyler Webb is the only one of the four quotes who is an arborist. Webb will care for the environment, will not use trucks or heavy equipment and has drawn out all the plans for removing each tree. The Board will approve the cut with Harding Hill Farm doing the work. The quotes are as follows: Harding Hill Farm - \$3800; New Hampshire Arbor Works LLC - \$4500; A Cut Above Tree Service - \$1800; JW Land Clearing - \$1300.

## b) Vannatta, School Board and Feneberg, Superintendent

Tom Vannatta, School Board member: Superintendent Feneberg and Lawrence LeBoeuf, business administrator came in to talk about the 2017/2018 school budget. They are working on the 5th revision of the budget. January 7th, 2017 is the delibortaive session. Feneberg said that the school budget is the biggest portion of tax bills for our seven towns. This is Feneberg second year here, he said this is a wonderful school district and we have a committed board of education. Most members have been here along time. The school budget is a complicated matter and there is a lot of money involved. My intention is to keep it steady and to steadily improve our children's education. We do have emergency money set aside. Our district has had several years of 100% of children graduating. We are trying to develop a budget that continues the good work that has been happening. We are working on future projects and preparing our students for a competive world. Technology is costly, but we need to educate our students and teachers. I do meet with all the principals of all our schools and set annual goals. Our budgets are 75% personnel, with consists of teacher contracts, retirement, health benefits and other benefits. Our existing septic system is on borrowed time at the high school, it has been there 47 years. We are looking at a new septic system and leach field. Also our para educators successfully negotiated a three year contract. We need to think long term, we do have aging buildings.

Pavlicek asked what is the proposing or projecting fund balance for next year. Leboeuf said it is 2% usually. Feneberg likes it steady but it is to early to tell yet. Nowell asked what is the projected enrollment for the future, Feneberg said it looks like a 100 kids up or down in the next ten years. As a district we have been pretty stable.

# 3 Regular Business

a) Department Head Discussion

Fire Department - Thomas - There were a lot of calls this week, firefighters have 14 to 18 plus hours. Calls were for accidents, medical calls, alarms, and Mountain Edge had a water issue. We have been receiving items this week on our open purchase orders. Also Thomas said they did have 75+% attendance for the active shooter awareness class and will be going for the grant which is not yet online.

Highway - Prussman - We had a lot of snow today. Four trailers of salt have been delivered. Prussman met with Mike Hansen of Hansen Bridge to discuss the bridge and guard rail issues. Hansen will work with CWS Fence and have another round of prices for us.

## b) John Greenwood

The Board received an email from Greenwood regarding fees for buffer zone tree cuts and septic design review. Greenwood would like to implement fees, Smith wants to see what other towns do. Pavlicek will check fee schedules with surrounding towns. Smith doesn't have a problem with the \$25 fee for septic review but the tree cut fee seems high. Nowell agrees. Thorson would like to have more information from other towns to see what they charge.

# c) TDS

Smith requested that we see if we can have TDS and Fairpoint come in and talk to us and let us know what is going on with the changeover and when it will be finished.
